2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a basic study of the HCC and lncRNA W5. The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: In this study, the authors investigate the role of Long non-coding RNA W5 in progression and predicting value of it in prognosis in hepatocellular carcinoma in vitro and in vivo.</p>	[Y]

The results are interesting and add valuable knowledge to HCC. However, there are some issues should be addressed. The manuscript needs to be carefully checked, and rewritten, several grammar mistakes need to be corrected. The reviewer suggests the authors use Cox survival analysis to further confirm the prognostic value of W5 for HCC. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 4 figures. A total of 26 references are cited, including 20 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Wenxing was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, the Institutional Animal Care and Use Committee Approval Form, and the ARRIVE Guidelines. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National High Technology Research and Development Program of China. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. This manuscript is the resubmission of manuscript No. 58975 (Withdraw). 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding

agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; (5) please don't include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. Statistical significance is expressed as $aP < 0.05$, $bP < 0.01$ ($P > 0.05$ usually does not need to be denoted). If there are other series of P values, $cP < 0.05$ and $dP < 0.01$ are used, and a third series of P values is expressed as $eP < 0.05$ and $fP < 0.01$.
