Report: This paper report Extracellular histones stimulate collagen expression and potentially promote liver fibrogenesis via TLR4-MyD88 signaling pathway. it would bring some new information in this area. However, there are some issues should be addressed. The data shown are minimal and additional experiments and data could make it an interesting paper. The fibrinogenesis process is more complex than only the synthesis of collagen. They must indicate it in their manuscript. The questions raised by the reviewers should be answered; and (3) Format: There are 4 4 figures. A total of 60 references are cited, including 10 references published in the last 3 years. There are 10 self-citations. 2 Language evaluation: Classification: Grade B, Grade B, Grade B, Grade B and Grade C. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and Institutional Animal Care and Use Committee Approval Form. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and fill out the ARRIVE Guidelines with page numbers. No academic misconduct was found in the Bing search. The authors have published preprint (<https://www.biorxiv.org/content/10.1101/2020.09.17.302240v1>).
