The topic is within the scope of the WJD. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The study is of interest, especially in the expansive field of diabetes and metabolic syndrome, entities that are growing worldwide and</p>	[Y]

demands new mechanistic knowledge and new therapeutic alternatives. However, the value of P and the post-hoc test employed should be indicated. The questions raised by the reviewer should be answered; and (3) Format: There are 11 figures. A total of 71 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, The ARRIVE Guidelines, the Institutional Animal Care and Use Committee Approval Form or Document, and the Institutional Review Board Approval Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJD. 5 Issues raised: The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
