The topic is within the scope of the WJG. (1) Classification: Grade B and Grade B; (2) Summary of the Peer-Review Report: The authors present an extremely rare case report and review of the literature about the</p>	[Y]

extrahepatic metastases of hepatocellular carcinoma (HCC). The authors diagnosed that HCC had hematogenous metastasis to the ileum and it developed in the lumen. Conservative treatment failed, and surgery was planned. The patients obtained long-term survival by multidisciplinary therapy. The questions raised by the reviewers should be answered; and (3) Format: There are 6 figures. A total of 21 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the CARE checklist form and informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 11%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors

	<p>did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) I found the “Case Presentation” did not meet our requirements. Please re-write the “Case Presentation” section. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, the full text of the manuscript, the relevant ethics documents, and the English Language Certificate, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
