(1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors report a 73-year-old man with AMI and renal failure who underwent hemodialysis and PCI, and developed a progressive decline in platelets and subcutaneous hemorrhage of both upper limbs after heparin treatment. interesting and well written. However, several issues should be considered to assess the results in this paper. Please describe the therapeutic agents in chronological order in Fig 5 for the readers to understand. The discussion is long, so please shorten it. The questions raised by the reviewers should be answered; and (3) Format: There are 5 figures. A total of 18 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and fill out the CARE Checklist-2016 with page numbers. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation
