However, some questions raised by the reviewers should be answered; and (3) Format: There are 2 figures. A total of 17 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the signed Copyright License Agreement. The authors should provide the Conflict-of-Interest Disclosure Form. The CARE Checklist-2016 lacks of the page number. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors' information should be added in the first page; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (5) The cited references should be superscript; and (6) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation.
