2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of virus load and virus shedding of SARS-CoV-2 and their impact on patient outcomes. The topic is within the scope of the WJCC. (1) Classification: Grade C, Grade C and Grade B; (2) Summary of the Peer-Review Report: This</p>	[Y]

manuscript entitled “Virus load and virus shedding of SARS-CoV-2 and their impact on patient outcomes” investigates SARS-CoV-2 virus shedding and its risk factors. The results showed that SARS-CoV-2 virus was identified in different samples, including the respiratory tract, blood, and eye discharge. The bronco-alveolar lavage fluid had the highest SARS-CoV-2 load. Senior patients had higher virus loads. Chloroquine was associated with shorter shedding duration and increased the chance of viral negativity; and (3) Format: There are 3 tables and 3 figures. A total of 24 references are cited, including 14 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and the Institutional Review Board Approval Form. Please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors

did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; (4) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author’s name, with no spaces; and (5) please don’t include any *, #, †, \$, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
