upon comprehensive and reliable analysis of current literature, this manuscript addresses the criteria for single stage revision arthroplasty while proposing future directions of research and clinical application; and (3) Format: There are 5 tables. A total of 47 references are cited, including 14 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: Please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Zimmer Biomet. The topic has not previously been published in the WJO. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section.
