The topic is within the scope of the WJSC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The study suggests that CH can improve bone</p>	[Y]

health in the elderly. However, it is unclear what age patients the MSC used for the in vitro experiments were obtained from. The questions raised by the reviewer should be answered; and (3) Format: There are 8 figures. A total of 93 references are cited, including 15 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. The signed Conflict-of-Interest Disclosure Form and Copyright License Agreement should be provided. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Government of Extremadura GAEDAF Research Group, "Ministerio de Educación, Cultura y Deporte", and CIBER "Fragilidad y Envejecimiento Saludable" (CIBERFES) of "Instituto de Salud Carlos III" (ISCIII), "Ministerio de Economía y Competitividad" (MINECO), Spain and European Union (EU). The topic has not previously been published in the WJSC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures.
