The topic is within the scope of the WJCO. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: There is a high incidence of cardiotoxicity caused by anthracyclines. For patients without risk factors, have you considered observing changes in heart function during treatment? For patients with risk factors, please show the</p>   | [Y]                            |

changes of cardiac function properly. It is noteworthy that the early detection and treatment of cardiotoxicity, even when asymptomatic, seems to be critical for cardiac function recovery and for the reduction of associated adverse cardiac events. Most importantly, the innovation of the article needs to be strengthened; and (3) Format: There are 3 tables and 1 figure. A total of 35 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Signed Informed Consent, and CARE Checklist – 2016. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCO. The corresponding author has 2 published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the “Case Presentation” did not meet our requirements. Please re-write the “Case Presentation” section, and add “FINAL DIAGNOSIS”, “TREATMENT”, and “OUTCOME AND FOLLOW-UP” section to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required. 7 Recommendation:
