reviewer should be answered; and (3) Format: There are 3 figures. A total of 41 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and the Institutional Animal Care and Use Committee Approval Form or Document, but didn't provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The ARRIVE Guidelines lacks of the page number. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by National Natural Science Foundation of China. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The language classification is Grade C.
