2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes an observational study of the effects of different statin application methods on plaque in patients with coronary atherosclerosis. The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The study is well designed and the manuscript is well written. However, the language needs some minor polishing. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables</p>	[Y]

and 1 figure. A total of 37 references are cited, including 3 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by SNAS was provided.

3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, STROBE Statement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search.

4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC.

5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text.
