indicators for determining the risk and severity of EV in patients with CHB related cirrhosis. The manuscript is well written: the title reflects the main subject of the article, abstract and keywords well summarize the arguments. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 5 figures. A total of 39 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Three Grades B. A language editing certificate issued by Nanjing KEY Translation Studio was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form. And the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Natural Science Foundation of Zhejiang Province of China. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The "Article Highlights"
