2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the adult-onset Still's disease evolving with multiple organ failure and death. The topic is within the scope of the WJCC. (1) Classification: Grade A and Grade D; (2) Summary of the Peer-Review Report: The manuscript is well elaborated and may come very handful to aid the knowledge of this syndrome. Reviewing of the literature was outstandingly performed and the</p>	[Y]

discussion is very enriching. However, the conclusion of the abstract does not support any relevant message. The total duration of corticosteroid therapy should be explained. More importantly, the authors should be very careful with the conclusion for cytokine storm syndrome. The patient had a strong immunosuppression (anti-IL6) and the authors seemed not to exclude cutaneous infection of the wound, osteomyelitis over osteonecrosis or an infection of the prosthesis. The patient may have died from septic shock. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table. A total of 57 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and the signed informed written consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The CrossCheck results showed the similarity to be as high as 33%. The highest single-source similarity index in the CrossCheck report showed to be 7%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) Please
