(1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The manuscript coded 59321 is an interesting article .In this manuscript, the authors report a rare case of isolated IgG4-SC,The experiences presented in the manuscript is useful to improve the readers' clinical practice. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 3 figures. A total of 28 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by Enago was provided. 3 Academic norms and rules: The authors provided the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the
