described with little precision and lack important details. Images with immunohistochemical or HE staining should be shown with scale bars. The number of patients evaluated with Kaplan-Meier analysis should be indicated. The questions raised by the reviewers should be answered; and (3) Format: There are 7 figures. A total of 30 references are cited, including 17 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and the Institutional Review Board Approval Form. The authors need to provide the Institutional Animal Care and Use Committee Approval Form, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and fill out the ARRIVE Guidelines with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Scientific and Technological Development Research Project Foundation of Shaanxi Province of China. The topic has not previously been published in the WJG. The corresponding author has published 3 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original

Statistical significance is expressed as aP < 0.05, bP < 0.01 (P > 0.05 usually does not need to be denoted).
