The topic is within the scope of the WJCC. (1) Classification: Grade C, Grade C, Grade C, Grade B and Grade D; (2) Summary of the Peer-Review Report: It is an interesting topic and the study was relevant. However, the authors should state</p>	[Y]

clearly their original findings, the key issues being addressed, and the clinical contribution to geriatrics. The polymorphism research by PCR should be further confirmed by DNA sequencing, and the Hardy-Weinberg balance should be assessed. It is suggested to change the title, to have different age groups, and to include a non-geriatric group. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables. A total of 41 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B, Grade B, Grade B and Grade B. A language editing certificate issued by Medjaden was provided. 3 Academic norms and rules: The authors provided the informed consent form and the Biostatistics Review Certificate. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form with a stamp and the STROBE statement filled with page number for each item. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s).
