Despite some interesting results, the study presents several aspects requiring further clarification before its consideration for publication. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables. A total of 40 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Shanghai Extender Medical Scientific & Technology Co. Ltd. was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Key R&D Precision Medicine Program and Shanghai Key Clinical Specialty Grant. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not add the PMID and DOI in the reference list. Please

Please revise throughout; and (3) I found the authors did not write the “article highlight” section.
