The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade B; (2) Summary of the Peer-Review Report: This was a good study of</p>	[Y]

neutrophil-to-lymphocyte ratio as a marker. The manuscript was well written; and (3) Format: There are 2 tables. A total of 34 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Changsha Shiyu Translation Service Co., Ltd was provided. 3 Academic norms and rules: The authors provided the STROBE statement with page numbers, the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Suzhou People's Well-being Project in China, Suzhou Maternity Disease of Clinical Center Project and Suzhou Introduction of Clinical Expert Team Project, China. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the title was more than 18 words. The title should be no more than 18 words (no acronyms should be included in the title); (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not write the "article highlight" section. Please write the "article highlights"

	<p>section at the end of the main text; (4) please don't include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. Statistical significance is expressed as aP < 0.05, bP < 0.01 (P > 0.05 usually does not need to be denoted).
