English literature; and (3) Format: There are 3 figures. A total of 29 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and Written Informed Consent and Institutional Review Board. Please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search.

4 Supplementary comments: This is an invited manuscript. The study was supported by Special Research Fund for Plastic Surgery Hospital, Chinese Academy of Medical Sciences and Peking Union Medical College and Beijing Municipal Science and Technology Commission - Functional Urethral Reconstruction of Hypospadias by Tissue Transplantation. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the language classification was grade C.
