behavioral changes in caerulein-induced recurrent acute pancreatitis. However, some questions raised by the reviewers should be answered; and (3) Format: There are 9 figures. A total of 130 references are cited, including 10 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Institutional Animal Care and Use Committee Approval Form or Document. However, the Biostatistics Review Certificate, and The ARRIVE Guidelines are not qualified. The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by United States Department of Veterans Affairs and United States National Institute of Health. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The "Article Highlights" section is missing.
