	<p>B, Grade C and Grade B; (2) Summary of the Peer-Review Report: This is a meaningful case study. It may enrich the genetic spectrum of juvenile-onset primary open-angle glaucoma (JOAG). Although further investigations on the functional effects of OLFM2 and SIX6 variants on JOAG should be performed, the report can be useful at the clinical level in terms of identification of further similar cases. This study is well written overall, and considered publishable after minor revisions. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. A total of 34 references are cited, including 12 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade A. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and the signed informed written consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Guangzhou Science and Technology Plan Project, Guangdong Natural Science Foundation and Research Funds of the State Key Laboratory of Ophthalmology. The topic has not previously been published in the WJCC.
