The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors presented a 46 years-old woman diagnosed with gastroesophageal varices that was eventually attributed to essential thrombocythemia. recent have reported this finding; and (3) Format: There is 1 table and 2 figures. A total of 10 references are cited, including 5 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors provided the written informed consent and CARE Checklist-2016. Please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. Without financial support. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation" section, and add "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" section to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
