| 2 | <p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of risk factors of post-hepatectomy liver failure in 80 patients. The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors found that the risk factors of PHLF in patients with liver tumors; they found that preoperative total bilirubin, PLT, APRI, and SV/LV are independent risk factors for PHLF. Both biochemical results and SV on imaging should be considered before</p> | [Y] |

establishing a surgical plan so as to minimize the risk of PHLF; the data were collected in detail. Statistical analysis is well done. The tables and figure are clear. Despite the great work to select the data, there is an important limitation about the small sample size; and (3) Format: There are 2 tables and 2 figures. A total of 25 references are cited, including 7 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
