The topic is within the scope of the WJGO. (1) Classification: Grade A, Grade B and Grade B; (2) Summary of the Peer-Review Report: This study utilized TCGA data for gastric cancer, and analyzed tumor mutation burden and miRNA signature for prognostic significance. The study is well designed and executed. The conclusion is reasonable based on the results. The manuscript is well written and</p>	[Y]

easy to read. However, there are some minor mistakes that need to be corrected. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 8 figures. A total of 49 references are cited, including 29 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A, Grade A and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and STROBE Statement. Written informed consent was waived. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Key Development Plan for Precision Medicine Research. The topic has not previously been published in the WJGO. The corresponding author has published 4 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not write the “article highlight”
