The topic is within the scope of the WJO. (1) Classification: Grade D and Grade C; (2) Summary of the Peer-Review Report: Clinical validity was assessed by comparing FJS</p>	[Y]

scores to the articular displacement. Please include much more point of views to assess the clinical validity. Please include a description of the social conditions. However, some questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. A total of 37 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, CONSORT 2010 Statement, Clinical Trial Registration Statement, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 17% in the CrossCheck report. The authors need to rephrase the repeated parts. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJO. 5 Issues raised: (1) The short title should be added; (2) The authors' information should be added; (3) The "Author Contributions" section is missing. Please provide the author contributions; (4) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (5) The reference' number in the square bracket should be superscript; (6)

	<p>PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (7) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor. The author needs to make a major revision according to reviewers' comments and CrossCheck report.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report and the full text of the manuscript, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
