2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a meta-analysis of the comparative profile for covid-19 cases from China and North America. The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This study evaluates the differences in profiles of clinical symptoms, comorbidities and disease biomarkers between China and North America. The idea has merit. However, there are some</p>	[Y]

issues with data affecting comprehensibility in full comparative profile. Some references should be added. The questions raised by the reviewer should be answered; and (3) Format: There are 4 tables and 1 figure. A total of 66 references are cited, including 38 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the PRISMA 2009 Checklist. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 9% in the CrossCheck report. The authors need to rephrase the repeated parts. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The “Author Contributions” section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text; and (5) The abstract should be an informative, structured abstract of no less than 350 words should accompany each manuscript.

	<p>Abbreviations should be avoided, but if used should be spelled out at first mention. The 5 sections of the structured abstract are: Background, Aims, Methods, Results, and Conclusion. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.
