Timeline	5	Information from this case report organized into a timeline (table or figure)	<u>P4</u>
Patient Information	6a	De-identified demographic and other patient or client specific information	<u>P4</u>
	6b	Chief complaint—what prompted this visit?	<u>P4</u>
	6c	Relevant history including past interventions and outcomes	<u>P4</u>
Physical Exam	7	Relevant physical examination findings	<u>P5</u>
Diagnostic Assessment	8a	Evaluations such as surveys, laboratory testing, imaging, etc.	<u>P5</u>
