C; (2) Summary of the Peer-Review Report: The author performs enucleation after TAE for Giant hepatic extra-gastrointestinal stromal tumor, and chemotherapy with imatinib after GIST is diagnosed in the pathological specimen. However, some questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 5 figures. A total of 37 references are cited, including 5 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the CARE Checklist-2016 and Written informed consent. The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Fundo de Incentivo à Pesquisa (FIPE)/Hospital de Clínicas de Porto Alegre and Universidade Federal do Rio Grande do Sul.. The topic has not previously been published in the WJGS. 5 Issues raised: (1) (5) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The “Case Presentation” section was not written according to the Guidelines for Manuscript
