Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The text is relatively well-organized with logical formatting, and it is of appropriate length. In laboratory examination, readers may not be accustomed to the normal values of the each laboratory data. It would be better to add the normal reference data. The questions raised by the reviewers should be answered; and (3) Format: There is table and 5 figures. A total of 30 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the CARE Checklist and informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJH. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence
