2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a observational study of the orthopaedic telephone consultations during COVID-19. The topic is within the scope of the WJO. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The article in review provides new data on the use of telephone calls for patient care in a busy orthopedic clinic in England.</p>	[ Y]

Unfortunately, this study lacks important points to get valid conclusion. The most important weakness is the absence of statistical analysis. It would be important establish a baseline with the affluence before COVID-19 pandemic. How it has been changed the telephone consultation? The differences on age, sex, motive of consultation and comorbidity of the patients should be added; and (3) Format: There are 2 tables and 2 figures. A total of 24 references are cited, including 14 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the Signed Informed Consent Form. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJO. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; and (2) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
