The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors present a case with occult breast cancer (OBC) with good results after neoadjuvant chemotherapy combined with</p>	[Y]

anlotinib. The manuscript is well and coherently organized, and the important data of the case are well presented; and (3) Format: There is 1 table and 4 figures. A total of 30 references are cited, including 8 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade A. A language editing certificate issued by MedE was provided.

3 Academic norms and rules: The authors provided informed consent and CARE Checklist-2016. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search.

4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Department of Finance of Jilin Province; and Jilin Scientific and Technological Development Program. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG.

5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references.
