The topic is within the scope of the WJCC. (1) Classification: Grade B, Grade B and Grade B; (2) Summary of the Peer-Review Report: The manuscript deals with an interesting and important argument, analyzed the causes of failure and recurrence of epiblepharon in children for the first time, and summarized the operation skills of reoperation. The topic has a clinical relevance. However, there are</p>	[Y]

some issues should be addressed. "DISCUSSION" should be focused on what they found and learned, and comparison with previous evidence. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. A total of 23 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, Institutional Review Board Approval Form, and informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; and (3) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the
