The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: It is the first reported case that SPTCL invading the CNS of long-term remission with lenalidomide maintenance therapy after initial treatment of HD-MTX. It suggests that lenalidomide may be effective in SPTCL cases involving the</p>	[Y]

CNS. The authors need to evaluate the regimen in a series of studies. The questions raised by the reviewers should be answered; and (3) Format: There are 6 figures. A total of 16 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Mogo Internet Technology was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016 and informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Wu Jieping Medical Foundation. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the title was more than 18 words. The title should be no more than 18 words; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
