2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the endoscopic mucosal ablation for colon polyps. The topic is within the scope of the WJG. (1) Classification: Grade B, Grade B and Grade B; (2) Summary of the Peer-Review Report: The paper described a novel technique using endoscopic mucosal ablation to remove polyps of the colon, especially for wide based polyps. From the limited number of case series, the authors</p>	[Y]

concluded the technique is safe, feasible and easy to master. The questions raised by the reviewers should be answered; and (3) Format: There are 6 figures. A total of 8 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. 3 Academic norms and rules: The authors provided the CARE Checklist-2016. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG.

5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation" section, and add "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" section to the main text, according to the Guidelines and Requirements for Manuscript Revision; (10) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the

	<p>end of the sentence with the citation content or after the cited author's name, with no spaces. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
