The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors analyzed the effectiveness of five fixations for acetabular posterior column fractures with three-dimensional models of normal and fractured pelvis using CT data</p>	[Y]

of the pelvis. The analysis is important and interesting and is useful for the management of acetabular fracture. However, there are some concerns that need to be addressed. The information on the precision of the analysis that the authors used for this study needs to be shown. More explanation is needed for Figures 4 and 5. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 5 figures. A total of 31 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, informed consent, and STROBE Statement. Institutional Review Board Approval Form was waived. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please
