The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors found that a patient with infectious pseudoaneurysm treated by endovascular stenting. The</p>	[Y]

prolonged and continued antibiotic therapy was chosen by susceptibility testing from the pseudoaneurysm. Eventually the hematoma was completely disappeared. This challenging endovascular treatment with appropriate antibiotics was an effective emergency treatment for this poor prognostic patient. Therefore this case presentation is worth publication; and (3) Format: There are 4 figures. A total of 13 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by KG Support Limited was provided. 3 Academic norms and rules: The authors provided the Informed Consent Form and CARE Checklist. Please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Sichuan Foundation of Science and Technology. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s).
