The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: Overall, this study is well written. The paper might bring great intention. If the authors complete minor revisions, the quality of the study will be further improved. The questions raised by the reviewers</p>	[Y]

should be answered; and (3) Format: There are 4 tables and 4 figures. A total of 15 references are cited, including 9 references published in the 2020. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by EditSprings was provided. 3 Academic norms and rules: The authors provided the informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and fill out the CARE Checklist-2016 with page numbers. No academic misconduct was found in the Bing search. The authors have published the preprint (<https://www.researchsquare.com/article/rs-21001/v1>). 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Central Public-interest Scientific Institution Basal Research Fund, Chinese Academy of Medical Sciences; Science and Technology Support Plan Fund of Zunyi City; and Science Plan Fund of Zunyi City. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that

all graphs or arrows or text portions can be reprocessed by the editor; (4) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (5) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation" section, and add "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" section to the main text, according to the Guidelines and Requirements for Manuscript Revision; (10) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces; and (6) Please write the "Conclusion" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
