A total of 78 references are cited, including 12 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C, Grade A and Grade C. 3 Academic norms and rules: No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJGS. 5 Issues raised: (1) The language classification is Grade C.
