The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade B; (2) Summary of the Peer-Review Report: The authors report two siblings with steroid-resistant nephrotic syndrome where they identified two novel compound heterozygous mutations in CRB2. The study is merit, but there are some issues need to be addressed. Minor English polishing is required. More information about CRB2</p>	[Y]

should be included in the introduction section. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. A total of 13 references are cited, including 4 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
