| 2 | <p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the clinical outcomes in patients with native valve infective endocarditis and diabetes mellitus. The topic is within the scope of the WJC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors studied the trends in the prevalence of DM, the demographics and</p> | [Y] |

co-morbidities among patients with native valve infective endocarditis (NVIE), and showed the impact of DM on in-hospital mortality using well-characterized database in the United States. The analysis was well organized, and the results were concordant with previous studies and gave further information in terms of the impact of DM on NVIE. However, some questions raised by the reviewer should be answered; and (3) Format: There are 5 tables and 2 figures. A total of 36 references are cited, including 10 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the official Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the
