2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a minireview of the vasoactive intestinal peptide and ulcerative colitis. The topic is within the scope of the WJG. (1) Classification: Grade A, Grade B, Grade C and Grade D; (2) Summary of the Peer-Review Report: This is a well written review paper concerning</p>	[Y]

the role of vasoactive intestinal peptide (VIP) in regulatory activity on intestinal immune response and its possible role in pathophysiology of ulcerative colitis. The topic is of clinical importance, however, the presentation of the review needs major revision. It comes not clear to the reader, why VIP is probably regulative in ulcerative colitis but not in the different types of Crohn's disease. The scheme/ graphical abstract is very simple and should be improved. The questions raised by the reviewers should be answered; and (3) Format: There is 1 figure. A total of 55 references are cited, including 22 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A, Grade B and Grade C. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China; Hongkou District Health Committee; and the sixth round of academic experience successors training project for Veteran Practitioner of Traditional Chinese Medicine, The document of the State Administration of Traditional Chinese Medicine 2017. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the language
