(1) Classification: Grade A, Grade D, and Grade C; (2) Summary of the Peer-Review Report: This report describes a well-conducted case of chondrosarcoma</p>	[Y]

affecting the upper part of the sternum. The authors demonstrate the innovative chest wall reconstruction method after Chondrosarcoma resection. However, the authors should a simple CT scan of the largest part of the lesion. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 7 figures. A total of 25 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A and Grade C. A language editing certificate issued by editage was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and Written informed consent. The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The language classification is Grade C.
