The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: In the description of the therapy, the authors highlight the main problems, and clearly</p>	[Y]

explain how you have overcome them. The use of mini-screws is widely reported in literature, and authors' choice of references is appropriate. The use of the anterior auxiliary arch to control the torque of the upper incisors is original, and the authors demonstrated that it can work in such a case. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 8 figures. A total of 15 references are cited, including 2 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade A. A language editing certificate issued by Filipoedia was provided.

3 Academic norms and rules: The authors provided the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search.

4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China, Sichuan Science and Technology Program. The topic has not previously been published in the WJCC.
