The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: High VA is a common indicator for the diagnosis of HE. And HE is a complication for</p>	[Y]

ACLF which has a prognosis role. Therefore, high VA as an inexpensive predictor of in-hospital mortality in patients with ACLF is lack of novelty. The important discovery in this paper is to find the cut-off value of VA. However, this point new finding can't support the publication of this manuscript. The questions raised by the reviewer should be answered; and (3) Format: There are 5 tables and 1 figure. A total of 26 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The Written informed consent is not right. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
