(1) Classification: Grade B; (2) Summary of the Peer-Review Report: The work is an interesting case report on a quite common event during hip reconstruction presenting the particularities of such event in a given patient with uncommon association of previous diseases. The manuscript is well organized, informative and of large interest for clinical experts in</p>	[Y]

anesthesiology as well as orthopedic surgeons. However, there are some issues should be addressed. Maybe more commentary is needed regarding the use and the moment of starting anticoagulant therapy, especially given the fact there was already peripheral vein thrombosis before surgery. The questions raised by the reviewers should be answered; and (3) Format: There 2 figures. A total of 17 references are cited, including 1 reference published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Edanz was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016 and informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the title was more than 18 words. The title should be no more than 18 words; (2) I found no "Author contribution" section. Please provide the author contributions; (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (4) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise
