sections and immunohistochemistry be preserved for so long time? and (3) Format: There is 1 table and 2 figures. A total of 19 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGO. 5 Issues raised: (1) The language classification is Grade C.
