(1) Classification: Grade B; (2) Summary of the Peer-Review Report: This case of brucellosis infection in shoulder highlights the importance of increasing awareness to help avoid misdiagnosis. Brucella spp. should be included among the considerations for differential diagnoses upon appearance of joint symptoms and dysfunction; and (3) Format: There are 6 figures. A total of 16 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Filipodia was provided. 3 Academic norms and rules: The authors need to provide the treatment informed consent, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 8%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China; and Natural Science Foundation of Liaoning. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s).
