The topic is within the scope of the WJGS. (1) Classification: Grade C and Grade C; (2) Summary of the</p>	[Y]

Peer-Review Report: This is a good ex vivo experimental study. The study was designed according to the standard endoscopic submucosal dissection procedure, and the research conclusion is true and reliable. However, the number of cases was significantly small, and the lesions were only limited in the middle or lower third of the stomach. The authors should explain why a clutch cutter was used, and provide details of complications. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 4 figures. A total of 22 references are cited, including 6 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade C and Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Institutional Review Board Approval Form or Document, the Biostatistics Review Certificate, and the ARRIVE Guidelines. The Institutional Animal Care and Use Committee Approval was waived. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGS. The corresponding author has published 6 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the

editor; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; (4) for statistical significance, please use superscript letters. Statistical significance is expressed as aP < 0.05, bP < 0.01 (P > 0.05 usually does not need to be denoted). If there are other series of P values, cP < 0.05 and dP < 0.01 are used, and a third series of P values is expressed as eP < 0.05 and fP < 0.01; (5) please write the “Conclusion” section at the end of the main text; (6) please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement; and (7) please provide the audio core tip file where the content of core tip is recorded. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
