(1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors describe the case report of the retroperitoneal resection simulated by 3D reconstruction and VR technique. well-documented. However, there are some issues should be addressed. Please describe the details about the process and program used for 3D reconstruction and VR technology. Please discuss more about the differences between real surgery and VR simulation. The questions raised by the reviewers should be answered; and (3) Format: There are 6 figures. A total of 10 references are cited, including 6 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the informed consent and CARE Checklist-2016. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6
